I am also troubled by the growth of support for George C. Marshall.

The common understanding for replacing Robert E. Lee is to have a Virginia representative that symbolizes a life of inclusion. Someone, whose lack of inclusion doesn't have to be excused and rationalized.

As president of the American Red Cross, George Marshall upheld the racial segregation of the nation's blood supply. That alone should disqualify him, and I'm surprised that wasn't already known to the Commission and used to negate this idea.

Add onto that, there doesn't seem to be evidence that he supported the racial integration of the Armed Serivces i.e.. the Japanese American 442nd, the Tuskegee Airmen, and women being given G.I Bill and other Veterans benefits while serving as an Army General.

While Secretary of State, Marshall did not usher in the hiring of minorities and women as full rank foreign service officers. It would be great to be wrong about this, but it isn't looking good for Marshall right now in this matter of diversity at State.

The Commission is encouraged to consider these factors before allowing it to gain further media presence, thus likely causing embarrassment to the Commission members for not catching this sooner.
